- Q2. The Drawings and Specifications call for double purchase guide wall located stage right to be reconfigured into a single purchase guide wall. Currently the J-guides stop at gallery level. In order to convert to full length, single purchase sets, the J-guides will need to be spliced in the same plane off the wall as they are currently located. This will push the lock rail onstage and the new lock rail here will not be aligned with the existing single purchase lock rail. In lieu of extending the existing guide wall, would it be acceptable to demo the existing double purchase guide wall and install a new single purchase guide wall here which will be full travel and in alignment with the existing lock rail? Please note that the new J-guide wall will be different construction than the existing aluminum track guides.
- A2. The J bar wall for the double purchase sets is to be moved back and closer to the wall to correct alignment with the arbor and purchase line to the stage level lock rail. Provide new wall knees and batten as necessary to achieve correct alignment of the existing rails to the new rails. If guide rails to match existing cannot be supplied, provide new J bar guide rails as necessary to ensure smooth travel.
